## COMPARE MEDICARE PLANS

Your Journey to Medicare is nearly complete. Medicare initial enrollment is open to you three months before, the month of, and three months after your 65th birthday. If you are applying for a Medicare insurance plan, it is usually best to apply for coverage two or three months before becoming Medicare eligible, so your Medicare insurance plan becomes effective at the same time as Medicare would have.



It is important to choose a Medicare insurance plan that meets your specific healthcare needs and also includes all of your trusted healthcare providers. 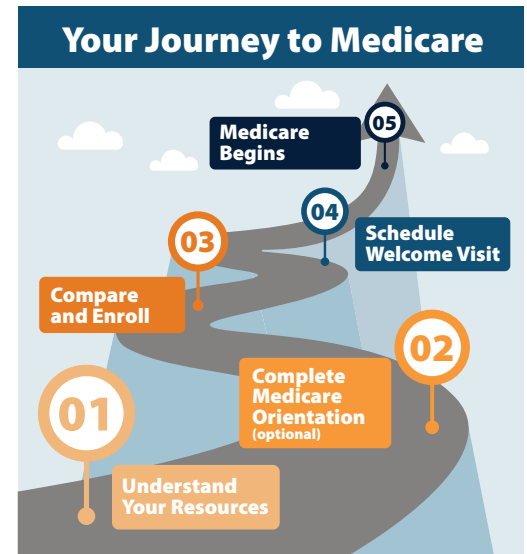
## Your Medicare Journey: You're almost at the finish line
